1) Highways Report.

a) Church Lane - PB has had a meeting with MP Peter Lilley at his Graveley Surgery on March 14th 2014 to discuss the Church Lane traffic problems, Peter Lilley will ask for a report and come back to GPC

b) Accidents - At the Junction of North Road and Graveley High Street PB drafted letters for Clerk to send to John Wood, Chief Executive, HCC and Peter Nicholls, Traffic Management Senior Officer, Hertfordshire Police Headquarters, pointing out the concern of the GPC and members of the public regarding the number of accidents at this Junction and request that a further investigation be carried out; Clerk also wrote to Rob Smith Deputy Director for Environment and Chief Consatable Andy Bliss. All replied but even though there were four traffic accidents in one week this accident spot is only ranked 118th equal with 5 other locations for hazardous sites. At the moment there are no plans to sort out the problems but Highways are planning better signs and cutting back foliage-GPC to keep an eye on progress. PB to draft a letter to John Wood for the Clerk to send.

2) Planning

Tony Bracey

a) Waste Recycling Centre- Land adjacent to B197, north of Graveley, Hertfordshire, SG4 7EQ.

Proposed amendment to size and height of 3 buildings at a waste recycling centre granted under planning permission 1/0574-12

Graveley Parish Council robustly opposes this application.

Reasons The proposed development is in the green belt and special circumstances need to be

demonstrated- special circumstances do not appear to have been demonstrated. Graveley Parish Council view that the proposed increase in size of the footprint of two buildings and the increase in height of three buildings as unsightly and a wholly inappropriate construction within the Green Belt, this will have a damaging impact on the countryside. The proposed changes particularly the increase in height of the buildings to 12mtres will not be in keeping with the rural nature of the site location .GPC wish to register strong objections to the increase in height to 12metres of building A as the proposed building is on the brow of a hill and will be a real carbuncle in the area.

Variation of condition 4 (hours of operation) of planning permission 1/0574-12 from 7.30 - 16.30 Monday to Friday and 7.30 - 12.30 on Saturdays to 06.00 - 18.00 Monday to Friday and 06.00 - 14.30 on Saturdays

Graveley Parish council oppose this application.

Reasons Increasing the weekday hours as requested would extend yard usage into the evening peak rush hour. The junction of the B197 is heavily congested at this time with long tailbacks of traffic waiting to join the dual carriageway. There is no information justifying the application, this can only indicate an increase in load volumes/vehicle movements over the originally approved total of 80 journeys (40 in & 40 out) per day and therefore the need for the yard to be opened longer. Although the yard is operational, there does not appear to have been any progress in complying with Point 9 of the conditions attached to the original planning application No 1/2645-10 (No operation of the site shall take place until a right hand turn lane has been constructed and brought into use in accordance with the drawings) therefore preventing the lorries accessing the site via Graveley, GPC strongly object to the possibility of lorries travelling through the village from 06.00 hrs-18.00 hrs.

b) Cars For Sale outside The Old Forge- TB is still pursuing this with Chris Braybrooke as there is still confusing as to who owns the land.

c) Car for sale in the layby- TB supplied the Clerk with photographs of a car for sale which he has emailed to Andy Goodman who will look into it and report back in due course.
