- b) Accidents Daniel Parker Assistant Engineer Development Management emailed PB: While the majority of the works were implemented during the autumn half term, there are a couple of minor snagging items to be resolved with Ringway. The works in relation to the embankment were not completed as they were identified in the Road Safety Audit and are still with the Developer to complete.
