## 1. Highways Report

## Jack Rigg

- a) Solar Panel Speeding Signs-JR has looked into the possibility of erecting in the High Street a sign to, hopefully, cut down the speeding in the High Street. The cost is approximately £4,000.00 per unit. They flash up a 'smiley face' if the vehicle is observing the speed limit and a 'grumpy face' if the speed limit is exceeded. The device also records the number of vehicles passing through the village and at what time. JR to see if it is possible to get a grant-TH has no more funds in his budget for this year but is willing to help when he can. JR to report at a later date with more information JR
- **b) Road Works at Junction of B197/North Road-** HCC (Martin Wright. Engineering Assistant) emailed a letter with plans for the proposed new Road markings in Graveley High Street. JR has drafted a letter, emailed to all GPC members, and will now supply the final version for the Clerk to send with GPC observations.

HN mentioned there was a problem with dangerous overhanging trees on back lane as you drive from Chesfield towards Calder Lane on Highways land and said she would e-mail TW to request the trees be cut down.
