The Clerk has spoken to our insurers, Came and Co, and sent them the quote, Clerk was under the impression that

we were covered as they asked for our Bank details and he had, in his email, asked specificity the question were we covered for the tree damaging the fence. Clerk has voiced his concerns at the way this request was dealt with as they have now told the Clerk we are not covered, even though the Playground is covered. Clerk has asked them to have a look at the whole matter and come back to him in due course.
