- **b) SBC Plan / Travellers Site** An extract of The Inspector's recommendations regarding the Travellers site is detailed below. The full report is available on the Graveley website under 'Village Information:-

"MM88. As set out above there is a demonstrable need for gypsy and traveller pitches within the Borough that cannot be accommodated on the existing Dyes Lane site. The Council have therefore had to look for a new site to accommodate this need. The Council have explored various alternatives, but because of the constrained nature of the Borough, with very little undeveloped non-Green Belt land remaining, no suitable, available sites were identified outside of the Green Belt."

This was discussed and JR put forward the proposal that we should, at this stage, seek further advice from our Solicitors to understand what options are available to us regarding possible future action.. JR asked the members of the public, who were present, for their views and they all agreed (13) as did all the GPC members that GPC obtain written legal advice as to whether grounds exist to appeal the decision of the Stevenage Examination Inspector's to support the establishment of a Travellers site HO12.JR to action.
