- b) NHDC Local Plan NHDC have now completed all of the Actions asked for by the Planning Inspector. These were asked for by the Planning Inspector to assist him to test the soundness of the Local Plan. However, these comments are not yet available for the public to view on the Actions List which is on the NHDC Local Plan Examination in Public website under the heading "Examination Actions". It is thought that the Inspector will ask all those who initially did their representations to comment on these Actions during a 6 week consultation anticipated to take place by Autumn 2018, but the exact timing of when this will be is dependent on the Planning Inspectorate.

**Sound Recordings**: CN asked SJ to find out if the recordings of all the NHDC Local Plan

Examination hearing sessions will be made available to the public. Both CN and Jack Rigg felt that this information is essential for members of the public who may wish to make further comment upon the Local Plan. The Examination in Public had been held in public and it was therefore strongly felt that the public should be allowed access to the recordings immediately. Previous local Examinations in Public had had almost immediate webcasts for the public to observe and listen to. Stevenage Borough Council had also provided recordings of their Local Plan Examination free of charge to the public on request.

**7. Parking in Ashwell Close-** RM contacted the Clerk. I've had a resident ask me if there's anything we can do regarding cars parking over the dropped kerb on the path coming down on same side as the parking spaces at the bottom. She states "It is difficult with a child's buggy to leave pave meant

to cross road due to cars parking across dropped kerb" Is this something we can raise? Clerk has emailed Heather Burrows to request the legal position-she is on leave.

- **8. Hedgerows** a member of the public raised an issue regarding a project to check whether there might be ancient hedgerows in Graveley, particularly in respect of the proposed Travellers Site and Church Lane. There is interest in this project from biodiversity enthusiasts from Letchworth Garden City who are keen to take part as volunteers. As they did not attend the meeting no action could be taken.
- **9. Cycle Route repairs**-update- Clerk has contacted Derek Jerrard and this has been completed. Clerk has thanked Derek.
- **10. Weeds-** Clerk was contacted regarding the overgrown weeds on the pathway leading from Pondside to the High Street (Between the two Public Houses) In the meantime TB has contacted the land owner who has agreed to carry out this work.
